Obtaining 100 CME credits each reappointment cycle is a requirement for reappointment to the Medical Staff. Documentation of your CME credits for the calendar years 2007 and 2008 will be needed by January 1, 2009 for your biennial reappointment. Each physician is responsible for collecting and maintaining their CME credit records.
